CNIM Group announces the closing of its divestment of Bertin IT and Vecsys to ChapsVision.

Following the second [conciliation protocol](#) signed on May 21, 2021 with its creditors, CNIM Group announces the closing of the divestment of the IT activities of its subsidiary Bertin Technologies, comprising Bertin IT and Vecsys, to ChapsVision. This transaction was announced in the press release published by CNIM Group on February 17, 2021.

These divestments are part of the measures provided for in the conciliation protocol and are intended to partially repay CNIM Group's medium-term debt.

Bertin IT and Vecsys specialize in the edition and integration of software solutions for cybersecurity, digital intelligence, business intelligence and speech processing.

Founded in 1856, CNIM is a French global industrial equipment manufacturer and supplier. The Group supplies products and services to major public and private sector organizations, local authorities and national governments in the Environment, Energy, Defence, and high technology markets. Technological innovation is at the heart of the equipment and services designed and produced by the Group. They contribute to the production of cleaner and more competitive energy, to limiting the environmental impacts of industrial activities, to making sensitive facilities and infrastructures safer and protecting individuals and nation states.
