The Group's order intake for the nine-month period ended 30 September 2020 totalled €342.0 million, including €215.3 million relating to Environment & Energy and €126.3 million relating to Innovation & Systems.

In the Environment & Energy Sector, the Group's order intake in 2020 includes an additional order relating to the Civil Works scope of the Lostock contract (in the North of England) and significant orders in its "flue gas treatment solutions for household waste-to-energy processing plants" activity.

Revenues for the nine-month period ended 30 September 2020 totalled €417.9 million, including €292.4 million relating to the Environment & Energy and €125.0 million relating to the Innovation & Systems.

The backlog at 30 September 2020 was €1,348.1 million, including €1,036.1 million relating to Environment & Energy and €312.0 million relating to Innovation & Systems.

It is 5.6% lower than the backlog at 1 January 2020 and represents 39 months of revenues.

# **Cash position**

At 30 September 2020, the Group had net debt of €161.9 million after taking into account gross cash of €132.2 million.

## **Outlook**

The implementation of the affiliation programme specified in the conciliation protocol could give rise to changes in the scope of the Group's activities between now and 2021. It was not possible to accurately forecast this impact at the end of the reporting period.

On a like-for-like basis, assuming that its E&E EPC and E&E Services Divisions will continue to negatively contribute to the Group's results and given the impact of the COVID-19 pandemic, the Group is forecasting a significantly negative EBITDA for 2020.
